

User Marketing Consent

This User Marketing Consent (the "**Consent**") is given by the consenting natural person (the "**User**") to Nufin GmbH, Saarbrücker Str. 37A, 10405 Berlin (the "**Company**") in connection with the provision of personal data by the User to the Company for the purpose of receiving marketing communications via email and/or telephone. By providing this Consent in accordance with Art. 7 GDPR, the User agrees to receive marketing emails and/or phone calls from the Company under the conditions set forth herein. The Company's Data Privacy Policy (available on www.getmoss.com) applies to the processing of personal data in this regard subordinate and contains further information, e.g. on the legal basis of the processing pursuant to Art. 6 (1) (a) GDPR, the storage period, the disclosure to recipients or third parties and recipients, the location of the data processing and the rights of the User under the GDPR.

1. Consent to Receive Marketing Emails

By giving consent, the User agrees to receive marketing emails (or other similar digital or electronic communication) from the Company, which may include promotional offers, regular newsletters, updates, and other marketing communications related to the Company's products, services and initiatives.

2. Consent to Receive Marketing Phone Calls

By giving consent, the User agrees to occasionally be contacted by the Company via the provided phone number to receive promotional offers, news, updates, and other marketing communications regarding the Company's products, services, and initiatives. If the User explicitly agrees to the recording of the phone call, the Company is entitled to process voice recordings of the conversation to automatically generate transcripts or summaries of the conversation and to use the results for the Company's internal purposes.

3. Marketing Communications by the Moss Group

This Consent also extends to receiving marketing communications referred to in Sections 1 and 2 above from companies affiliated with the Company within the meaning of sections 15 et seq. German Stock Corporation Act (AktG) (the "**Moss Group**").

4. Voluntary Consent

This Consent is voluntary, and the User is not obligated to give such consent. The User can unsubscribe from each marketing channel individually at any time, as further explained in Section 6 below.

5. Personal Information

The User is aware that giving consent may involve the collection, use, and processing of their personal data, including but not limited to their name, email address, phone number, and other information voluntarily provided by the User for marketing purposes, such as interest in certain products and services or information useful for providing appropriate service. The User acknowledges that the Company handles personal data in accordance with applicable data protection laws and the Company's Data Privacy Policies.

6. Right to Withdraw Consent

The User has the right to withdraw their consent at any time without incurring any costs. The User can unsubscribe from marketing emails by following the "Unsubscribe" or "Opt-out" instructions included in the respective email sent by the Company. The User can opt-out of marketing phone calls by contacting the Company or its Data Protection Office at the contact address provided in the Company's Data Privacy Policy. Upon receiving an opt-out request, the Company will promptly block or delete the User's email address and/or phone number for marketing purposes. Other rights of the User remain unaffected.

7. Governing Law and Jurisdiction

This Consent shall be governed by and construed in accordance with the laws of Germany. Any dispute arising out of or in connection with this Consent shall be subject to the exclusive jurisdiction of the courts of Berlin, Germany.

By consenting to marketing communications, the User acknowledges that they agree with the scope of the foregoing Consent and the additional conditions.
